

Terms of Service

The University of Cambodia Foundation provides its services (described below) to you through its website and mobile applications (the "Platform") and related services (collectively, such services, including any new features and applications, and the Platform, the "Services"), subject to the following Terms of Service (as amended from time to time, the "Terms of Service"). For purposes of the following Terms of Service, "The University of Cambodia Foundation," "the Institution," "we," "us," "our," and other similar terms, shall refer to the party with whom you are contracting. We reserve the right, at our sole discretion, to change or modify portions of these Terms of Service at any time. If we do this, we will post the changes on this page and will indicate the date these terms were last revised. We will also endeavor to notify you, either through the Services user interface, in an email notification or through other reasonable means, and unless otherwise stated, The University of Cambodia Foundation may communicate with you officially by any reasonable means now known or later developed. These currently include email, regular mail, and postings on the Platform. Any such changes will become effective no earlier than fourteen (14) days after they are posted, except that (i) changes addressing new functions of the Services or changes made for legal reasons will be effective immediately, and (ii) changes or modifications to the provisions of these Terms of Service governing Dispute Resolution By Binding Arbitration shall be made as specified therein. Your continued use of the Services after the date any such changes become effective constitutes your acceptance of the new Terms of Service. To the extent allowed by law, the English version of these Terms of Service is binding and other translations are for convenience only. If you do not wish to accept the new Terms of Service, you may discontinue your use of the Services.

In addition, when using certain services, you will be subject to any additional terms applicable to such services that may be posted on the Services from time to time. All such terms are hereby incorporated by reference into these Terms of Service (provided, however, that such other terms may be modified in accordance with their terms and, with respect to the use of the Services, these Terms of Service will take precedence in the event of conflict).

Finally, we encourage you, particularly if you intend to donate to The University of Cambodia Foundation, to review each section carefully of these Terms of Service.

Terms of Service and Privacy

The University of Cambodia Foundation does not sell any donor information to other organizations. All donors must agree to the terms and conditions provided. The Foundation keeps confidential and secure your addresses, phone numbers, email addresses, contribution amounts, credit card numbers and other types of personal information. If you have provided us with your contact information, you may receive periodic communication from us by mail, phone and email. Cookies

Cookies are small text files placed on your device by websites you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the

owners of the site. The cookie information we collect for these purposes is anonymous and helps to expedite your re-entry to our website.

Encryption

When you donate on our website, you will be asked to provide your name, contact information, and credit card billing information. All of this information is encrypted using "SSL," an industry standard secure technology. This encryption is designed to prevent the theft or interception of the information you provide. SSL encryption is indicated on your web browser by the display of a lock or key on the browser status bar.

Other elements of security

In addition to using SSL encryption for all transactions, Payway.ababank.com encrypted credit card numbers and passwords, as well as other donor information, on servers that are kept in a physically secure environment with strict policies that minimize staff access to the information contained therein.

Access and Use of the Services

Services Description: The Services offered on the platform allow donors and other registered users of the Services ("Donors") to donate cash funds directly to The University of Cambodia Foundation. The platform allows Donors to allocate donations to a variety of Funds, Projects, Programs, or Initiatives. Platform Services also include recognition for Donors through a variety of avenues to be specified on a case-by-case basis to be determined individually by the Donor and the Institution at the time of the donation.

Charitable Giving: According to a Prakas from the Royal Government of Cambodia, there is a tax holiday for income related to education until 2018. There is no profit tax of 20% for annual income, nor is there a 1% tax for monthly income. This would apply to scholarships and any donations related to education.

In addition to the Services described above, The University of Cambodia Foundation permits Donors to contribute directly to certain funds ("Funds") and can be specified further for specific projects or programs through the Platform. Any donation you make to a Fund through the Platform will be subject to a Services fee from ABA bank, but not from The University of Cambodia. The actual fees are set by the bank, and not the university itself.

The Services are a Platform; We are not a Broker, Financial Institution, Creditor or Charitable Institution: The Services are an administrative platform only. The University of Cambodia Foundation Platform facilitates the Donation transaction between Donors and the Institution. The University of Cambodia Foundation is not a broker, agent, financial institution, creditor or insurer for any user. The University of Cambodia Foundation has no control over the conduct of, or any information provided by, Donors, and The University of Cambodia Foundation hereby disclaims all liability in this regard to the fullest extent permitted by applicable law.

The University of Cambodia Foundation does not guarantee that Donations to Funds will fulfill the requirements of specific projects and thus cannot guarantee that projects will be implemented immediately or in the future. Projects must be fully funded before the Institution can implement

the project. However, Donations will only be used for the express purpose designated by the Donor at the time of the Donation. We expressly disclaim any liability or responsibility for the success of any Fund, Project, Program or Initiative, or the outcome of any fundraising purpose. You, as a Donor, must make the final determination as to the value and appropriateness of contributing to any Fund, Project, Program or Initiative.

While we have no obligation to verify that the use of any funds raised has immediate or future success for the designated purpose in accordance with applicable law and these Terms of Service, we take possible fraudulent activity and the misuse of funds raised very seriously. If you have reason to believe that the Institution is not raising or using the funds for their stated purpose, please contact us at info@universityofcambodiafoundation.org

Your Registration Obligations: You may be required to register with The University of Cambodia Foundation in order to access and use certain features of the Services. If you choose to register for the Services, you agree to provide and maintain true, accurate, current and complete information about yourself or your Institution as prompted by the Services' registration form. Donors must register using their true identities, including their name and any other information listed on the registration form. However, Donors may remain anonymous to the public if they select this option on their registration form. Registration data and certain other information about you is governed by our Privacy Policy. If you are under 13 years of age, you are not authorized to use the Services, with or without registering. In addition, if you are under the age of majority in your jurisdiction (typically 18 or 19 years of age), you may use the Services, only with the approval of your parent or guardian. Certain aspects of our Services may also require you to register with, and agree to the terms of, third-party service providers (e.g., payment processors) in order to utilize such Services. For example, ABA Bank is one of The University of Cambodia Foundation's payment processing partners. When you use ABA Bank's services, your right to use such services is strictly confidential for the purpose you provide in the details of your registration. You may not resell, hire, or on any other basis, allow third parties to use the payment services to enable such third parties to be paid for their services. You may not use the payment services for any different purpose than as registered with our application. If The University of Cambodia Foundation or ABA Bank at any time discovers that the information you provided about you or the purpose of your Donation is incorrect or changed without informing us or if you violate any of these conditions, the services may be suspended and/or terminated with immediate effect and fines may be applied by the Credit Card Schemes and/or the authorities for unregistered use of payment services which will in such case be payable by you. The University of Cambodia Foundation will assist and support you in your use of the payment processing services to be provided by ABA Bank (i.e., the Processor) and we will provide you with first-line assistance with and enable you to connect to the systems of ABA Bank to be able to use its services. For this purpose, you understand that you are instructing ABA Bank to provide The University of Cambodia Foundation with access to your data and setting in ABA Banks systems, which are used by ABA Bank to provide the services and authorize us to manage these on your behalf. While we may help facilitate such registration in some cases in connection with payment processors with which The University of Cambodia Foundation has partnered, we are not a party to any such relationships and disclaim any responsibility or liability for the performance by such third parties. We may exchange information with such third-party services in order to facilitate the provision of Services (and related third party services). Where such information consists of Personal Data (as defined in the Privacy Policy), it will only be shared in accordance with the Privacy Policy.

Taxes: It is your responsibility to determine what, if any, taxes apply to the Donations you receive through your use of the Services. It is solely your responsibility to assess, collect, report or remit the correct tax, if any, to the appropriate tax authority.

Member Account, Password and Security: You are responsible for maintaining the confidentiality of your password and account, if any, and are fully responsible for any and all activities that occur under your password or account. You agree to (a) immediately notify The University of Cambodia Foundation of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you sign out from your account at the end of each session when accessing the Services. The University of Cambodia Foundation will not be liable for any loss or damage arising from your failure to comply with this Section.

Modifications to Services: The University of Cambodia Foundation reserves the right to modify, suspend or discontinue, temporarily or permanently, the Services (or any part thereof). We will endeavor to give you notice of any such modification, suspension or discontinuance. You agree that, to the extent permitted by law, The University of Cambodia Foundation will not be liable to you for any modification, suspension or discontinuance of the Services in accordance with these Terms of Service.

Public Display of Donations: As a Donor, you have the option to publicly display your Donation for all to see, including on search engines (like Google and Yahoo). To keep the details of your Donation private, simply click on the donation page that you would like to remain anonymous.

General Practices Regarding Use and Storage: You acknowledge that The University of Cambodia Foundation may establish general practices and limits concerning use of the Services, including without limitation the maximum period of time that data or other content will be retained by the Services and the maximum storage space that will be allotted on The University of Cambodia Foundation's servers on your behalf. You agree that The University of Cambodia Foundation has no responsibility or liability for the deletion or failure to store any data or other content maintained or uploaded by the Services. You acknowledge that The University of Cambodia Foundation reserves the right to terminate accounts that are inactive for an extended period of time, provided that The University of Cambodia Foundation will use its commercially reasonable efforts to provide a Donor with reasonable notice before terminating an inactive account. You further acknowledge that The University of Cambodia Foundation reserves the right to change these general practices and limits at any time, in its sole discretion. We will endeavor to give you notice of any such change where required by applicable law.

Donations: In order to contribute to a Fund, Project, Program or Initiative, Donors will be required to provide The University of Cambodia Foundation information regarding its credit card or other payment instrument. You, as a Donor, represent and warrant to The University of Cambodia Foundation that such information is true and that you are authorized to use the payment instrument. You agree that a certain minimum Donation amount may apply, and that all Donation payments are final and will not be refunded unless The University of Cambodia Foundation, in its sole discretion, agrees to issue a refund, for example in accordance with the The University of Cambodia Foundation Guarantee. Donors may have the option to contribute recurring period Donations, and in electing to contribute on a recurring basis, you, as a Donor (i) agree to promptly update your account information with any changes (for example, a change in your billing address or credit card expiration date) that may occur and to pay the Donation amount that you specify, and (ii) hereby authorize The University of Cambodia Foundation to bill your payment instrument in advance on a periodic basis until you terminate such periodic payments, which can be done at any time through the Platform.

Fees: In addition to the specified Donation amount Donors may be subject to an additional payment processing fee which will be added to the total amount of the specified Donation and is payable directly to our payment partners (the "Payment Processing Fee.") ABA Bank charges a small amount for each transaction, and the bank itself sets that rate. The University of Cambodia does not charge a fee for the donations. Donors acknowledge that by contributing a Donation to a Fund, Project, Program or Initiative the Donor is agreeing to any and all applicable terms and conditions set forth by our payment partners, in addition to these Terms of Service, including ABA Bank's Terms and Conditions. Fees are added directly to each Donation, and will not be reflected in the amount that a Donor specifies for Donation to a Fund.

Special Notice for International Use; Export Controls: Software (defined below) available in connection with the Services and the transmission of applicable data, if any, may be subject to export controls and economic sanctions laws of the Kingdom of Cambodia or other jurisdictions. No Software may be downloaded from the Services or otherwise exported or re-exported in violation of such export control and economic sanctions laws. Downloading or using the Software

is at your sole risk. Recognizing the global nature of the Internet, you agree to comply with all local rules and laws regarding your use of the Services, including as it concerns online conduct and acceptable content.
