Donation Agreement between The University of Cambodia and a Donor for the UC Foundation

You hereby declare that you not involved in any criminal or money laundering activity and the funds are clean and clear and are not derived from any illegal activities.
2. If you make a donation over \$10,000, please scan your government ID or passport and send the information to info@universityofcambodiafoundation.org.
3. The University of Cambodia reserves the right to decline or return donations at its sole discretion.
4. As the donor, you have the right to choose whether you want your donation to go to a specific purpose, or you can allow The University of Cambodia to allocate it for general purposes. These general purposes include improving the facilities, enhancing education services, supporting research projects, building new campuses in the provinces, providing scholarships to needy and deserving students, increasing teaching excellence, constructing new buildings such as dormitories for students and lecture halls, contributing to the UC Endowment Fund and so forth.
5. The personal information provided to enable an online donation – such as your name or email address – will not be shared with any third party, other than those necessary to record and process your donation in accordance with the laws and regulations in the Kingdom of Cambodia.
6. The University of Cambodia will respect the wishes of donors if they want to remain anonymous and will not share their name and/or organization publically.
7. Should your personal information be accessed by an unauthorized third party through any action beyond our reasonable control – such as unauthorized access to our data base- you indemnify The University of Cambodia from any damage you may suffer as a result of such disclosure.
8. Donations are non-refundable and cannot be cancelled or returned once processed. If you become aware of fraudulent use of your card, or if it is lost or stolen, you must notify your card provider in accordance with its reporting rules.
9. As the recipient, The University of Cambodia will be responsible for all taxes in relation to donations. The donor will not be accountable for this.
10. In accepting this donation, The University of Cambodia will be fully compliant with existing laws and regulations in the Kingdom of Cambodia.
